If you do not have one, please submit a "Grading Application Form" which has been verified by your club to the Cycling Queensland office at least fourteen (14) days prior to the event you wish to enter. 5 DECLARATION

In consideration of the acceptance of this entry in the competition by the Queensland Cyclist Association Inc hereafter called Q.C.A. and or its agents:

- I hereby agree to comply with all the rules and regulations & event instructions of Q.C.A and their directors
- For myself, my executors, administrators, heirs, next of kin, successors and assigns, I hereby (a) waive and release all claims I may have against Q.C.A their officer, directors, event committee, volunteers, employees, agents and sponsors, the State of Queensland, the local shire council or any one or more of them or their executors, administrators, heirs, next of kin, successors or assigns ('the release') including any and all claims for damages caused by the negligence of any of the above arising out of my participation in the event or it's related activities, together with any costs including attorney's fees that may be incurred as a result of such claim whether valid or not, and (b) indemnify and hold harmless the releases and each of them against any such claim that I or my guests or anyone or more of the executors, administrators, heirs, next of kin, successors and assigns may have or assert and against any costs including attorney's fees with respect there of.

- I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and or illness during the competition.
- Event photos taken by Cycling QLD accredited photographer/s are made available for sale by that photographer/s remain the property of Cycling Queensland and may be used by Cycling Qld for promotional purposes, however, you may **request in writing, prior to the event**, that images of you, your immediate family members or persons of legal responsibility are not published, either for sale or used as promotional purposes by Cycling Queensland
- Entries must be received by the advertised closing date.** Late entry subject to the Late Entry Policy (CQ website)
- A current racing licence must be produced at registration at least 30 minutes before race start.
- Riders compete at their own risk. Fines will be imposed for race collusion and unsatisfactory performance.
- Riders who withdraw from events and who produce a valid medical certificate may authorise CQ to use the proceeds of the refund, otherwise payable, to be credited against future race entry fees. Please note the credits remaining after 12 months shall become income of CQ. An admin fee of \$5 applies.
